

Nigeria's Central Bank Pledges Support for Youth-Led Economic Growth

he Central Bank of Nigeria has reaffirmed its commitment to empowering young Nigerians through youthfriendly credit policies and capacity-building programmes to foster economic growth and innovation.

Speaking at the Youth Action Event in Abuja on Friday, the CBN Governor, Olayemi Cardoso, who was

represented by the Deputy Muhammad Abdullahi, stated that the apex bank remained dedicated to providing young people with the necessary financial tools to succeed.

He further emphasised that the bank's policies would support youth entrepreneurship and innovation, particularly in emerging sectors such as the green economy and digital transformation.

Cocoa, Fertiliser Lead, As Non-oil Exports Rise To \$5.46bn

to the recorded figure of US\$4.517 billion for the preceding year of 2023," Ayeni said.

Cocoa Beans accounted for 30.55 per cent of total non-oil exports, while Urea/Fertilizer contributed 15.74 per cent, underscoring the pivotal role of agriculture and industrial exports in Nigeria's economic diversification efforts.

She further attributed the growth to enhanced production in key sectors such as agriculture, solid minerals, and manufacturing, alongside trade policy reforms under President Bola Ahmed Tinubu's agenda.

On key drivers of growth, NEPC identified several factors that fueled the sector's performance, including, Increased production of agricultural and industrial commodities such as Cocoa, Urea/Fertilizer, and Sesame Seeds.

Federal government efforts to enhance trade policies and market access and increased participation in regional and international trade agreements.

"The impressive performance in 2024 reflects the success of our #doubleyourexport campaign, Export 35 Redefined initiative, and strengthened advocacy for non-oil exports,"

Ayenistated.

She added that a total of 246 distinct products were exported in 2024, spanning manufactured goods, semiprocessed commodities, and rawmaterials. This is apart from Cocca Beans and Urea/Fertilizer, Sesame Seeds, Cashew Nuts/Kernels, Aluminum Ingots, Cocca Butter, Copper Ingots, Soya Beans/Meal, Gold Dore, and Hibiscus Flower ranked among the most exported products.

Cocoa Butter, in particular, witnessed a notable surge in demand, entering the top 10 export list due to improved processing and favorable market conditions.

Among exporting companies, Indorama Eleme Fertilizer and Chemical Limited and Starlink Global & Ideal Limited led the pack, with export earnings of \$475.3 million (8.71 per cent) and \$456.7 million (8.37 per cent), respectively. Their dominance was largely due to large-scale exports of Fertilizer and Cocoa products.

"Of the top 20 exporting companies in Nigeria, Indorama Eleme Fertilizer and Chemical Limited and Starlink Global & Ideal Limited secured the foremost position with \$475,309,887.26, representing 8.71 per cent and \$456,740,920.00, representing 8.37 per cent respectively. This is attributed to their notable export volumes of Fertilizer and Cocoa products,"

Ayeni acknowledged that Informal Cross-Border Trade (ICBT) plays a crucial role in Nigeria's non-oil export landscape, with its contributions yet to be fully captured in official figures. She emphasised the need for improved mechanisms to integrate and record these transactions to reflect the true scale of Nigeria's export potential.

"It is also interesting to note that there was an increase in the volume of agricultural commodities as non-oil export returns showed that 7.291 million metric tonnes of exportable products were exported in the period under review. More importantly, the result for 2024 would have been much more considering that the volume of Informal Cross Border Trade (ICBT) represents a reasonable percentage of our exports.

Looking ahead with the positive trajectory of non-oil exports, the NEPC reaffirmed its commitment to strengthening export promotion strategies, increasing value addition in key commodities, and expanding market access through global trade partnerships.

The Council remains optimistic that with continued policy support and private sector participation, Nigeria's non-oil export earnings will surpass current records in the coming years.

CBN Plans To Curb Inflation, Stabilise Economy – *Cardoso*

The Governor of the Central Bank of Nigeria (CBN), Olayemi Cardoso, says the apex bank is determined to curb inflation and stabilise the nation's economy.

He stated this in Abuja during the Monetary Policy Forum 2025, featuring fiscal authorities, legislative, private sector, development partners, subject-matter experts, and scholars.

Speaking on the theme, 'Managing the Disinflation Process,' the apex bank boss reiterated that the goal of the CBN is to ensure that monetary policy remains forwardlooking, adaptive, and resilient. He said the CBN is continuing its disciplined approach to monetary policy.




"Managing disinflation amidst persistent shocks requires not only robust policies but also coordination between fiscal and monetary authorities to anchor expectations and maintain investor confidence.

"Our focus must remain on price stability, the planned transition to an inflation-targeting framework, and strategies to restore purchasing power and ease economic hardship," Cardoso said.

He stated that actions taken by the CBN have yielded measurable progress – relative stability in the FX market, narrowing exchange rate disparities, and a rise in external reserves to over \$40 billion as of December 2024.

Banks Adhere to Court Order Lifting Asset Freeze on GHL Directors

eneral Hydrocarbons Limited (GHL) has confirmed T that financial institutions have fully complied with a Federal High Court ruling that revoked the Mareva injunction imposed on assets belonging to its directors and shareholders.

Following the ruling, First Bank had maintained that GHL and its directors were still bound by court restrictions, asserting that they remained barred from accessing funds in their accounts or managing their assets.

However, GHL countered these claims, accusing the bank of "deliberately and maliciously spreading misinformation about the clear and unambiguous ruling of the learned judge.

The company emphasized that banks had complied with the court's directive despite "false and misleading statements from FBN Chairman, Femi Otedola, Managing Director Olusegun Alebiosu, and their legal representatives."

"This deception is the latest in a series of dishonest actions by First Bank of Nigeria, which has left the public shocked and disappointed that a reputed financial institution in a democratic country like Nigeria would stoop so low as to willfully disobey the law and propagate falsehoods without remorse," the statement read.

GHL also stated that it intends to challenge the credibility of the bank's audited financial reports, which were used for its recent rights issue.

The company recalled that First Bank had obtained the Mareva injunction by failing to disclose an existing judgment from the Federal High Court, Lagos Divi-sion. As a result, GHL has initiated multiple legal actions across different jurisdictions, seeking damages for defamation, libel, and breach of contract.

Additionally, GHL asserted that it would "continue to pursue justice globally against First Bank for breaching its contractual obligations, having benefitted without fulfilling its commitments."

The company also questioned the accuracy of First Bank's financial statements, arguing that its restated figures—where a previ-ously declared N306 billion loss transformed into a N151 billion profit-should be subjected to legal scrutiny.

The dispute between GHL and First Bank stems from a loan agreement linked to an Oil Mining Lease, with GHL alleging that the bank failed to meet its contractual obligations under the agreement.

Mobile Money: Palmpay, OPay, others Process N71.5 Trillion Transactions in 2024

Nigeria Inter-Bank Settlement Systems (NIBSS) has revealed that licensed mobile money operators including Palmpay, OPay, and 15 others processed transactions valued at N71.5 trillion between January and December 2024.

This represents a 53.4% increase in transactions across mobile money platforms when compared with the N46.6 trillion recorded in the full year 2023.

The volume of transactions across the fintech platforms also increased by 23%, jumping from 3 billion in 2023 to 3.9 billion in 2024, according to NIBSS data.

Meanwhile, the mobile money operators in Nigeria are anticipating a bigger boom in transactions this year on the back of a projected increase in smartphone penetration in Nigeria.

It was recently reported that there are currently 17

he latest data companies licensed by the Central Bank of Nigeria as Mobile Money Operators.

While the mobile money operators could also be referred to as fintechs, there are over 200 fintechs in Nigeria but only 17 are licensed as mobile money service providers.

Meanwhile, the growth in transactions was recorded despite a onemonth setback for some of the leading mobile money operators, who were momentarily stopped from onboarding new customers by the Central Bank of Nigeria (CBN)

The CBN had in April 2024 ordered OPay, Palmpay, Paga, and other fintechs not in the mobile money space including Moniepoint and Kuda Park to stop opporting Bank, to stop onboarding new customers over the sus-picion that their platforms are being used by criminal elements to maneuver foreign exchange through crypto trading. FX Code Revolution: Nigeria's Equity Market on the verge of Transformation

he Central Bank of Nigeria (CBN) has announced that the forensic verification of the \$7 billion foreign exchange (FX) backlog is nearing completion. This significant development is part of the CBN's ongoing efforts to enhance transparency, ethical conduct, and governance in Nigeria's FX market.

The FX backlog issue has been a major concern for the Nigerian economy, affecting multinational businesses and investors who have been unable to repatriate their funds. The backlog, which stood at \$7 billion, has been a source of frustration for many stakeholders. The CBN's commitment to resolving this issue is seen as a crucial step towards restoring confidence in the Nigerian FX market.

The forensic verification process, initiated by the CBN, has been thorough and meticulous. According to CBN Governor Olayemi Cardoso, the process uncovered a high level of unethical practices that had contributed to the backlog. 'We also looked at the unverified ones, and I believe that we ket. The clearance of the backlog will enable multinational businesses and investors to repatriate their funds, thereby boosting investor confidence. "We are going to ensure that we do what we need to do to strengthen our market and create a better trust in what you investors naturally desire and deserve," Cardoso added.

The CBN's efforts to address the FX backlog are part of a broader strategy to stabilize the Nigerian economy. The introduction of the Nigeria FX Code, which outlines principles of good practice, is aimed at ensuring a robust, fair, and transparent FX market. The code applies to autho-rized dealers licensed under the CBN Act 2007, the Bank and Other Financial Institutions Act 2020, and other institutions engaged in wholesale FX business.

Compliance and Enforcement: To ensure strict adherence to the FX Code, the CBN has mandated market participants to perform a selfassessment and submit a compliance report detailing their adherence to the code. This report must be endorsed by the participant's board of directors and include an implementation plan to address any compliance gaps. Institutions are also required to provide extracts of the relevant board meeting minutes to demonstrate oversight. Beyond the initial submission deadline, quarterly compliance reports must be filed with the CBN's Financial Markets Department (FMD). These reports are due within 14 days of the end of each quarter, with the first report expected by March 31, 2025. The CBN has outlined enforcement mechanisms, including monetary penalties, as provided under the CBN Act 2007 and the Bank and Other

Strengthening Integrity: The CBN's directive highlights its commitment to promoting a more resilient and transparent FX market. The FX Code aims to foster confidence among market participants, ensuring that transactions reflect competitive pricing and align with global behavioral standards. Market participants are urged to align their operations with the principles outlined in the FX Code to avoid penalties and support the overall stability of Nigeria's FX market.

Nigeria's FX Reserves Drop by \$832.6m Amid Rising Debt Eervicing

Nigeria's foreign exchange reserves have fallen by \$832.62 million in two weeks – between January 6 and January 21 – hurting the country's reserves that have enjoyed relative stability and growth for about five months, as per data from the Central Bank of Nigeria (CBN).

Data from the apex bank show that Nigeria's FX reserves stood at \$40.92 billion on January 6, 2025. However, by January 21, the figure had declined to \$40.09 billion, representing a 2.03 percent decrease inafortnight.

Thiswas reported on the 15th of January that the country's foreign currency reserves decreased by \$320 million, representing a 0.8 percent drop, plunging from \$40.88 billion on January 2, 2025, to \$40.56 billion.

This sharp decline highlights the pressures on Nigeria's reserves amidst ongoing currency market challenges and macroeconomic uncertainties.

Analysts have attributed this decline to two main factors - international debt servicing obligations and foreign exchange interventions by the CBN.

Nigeria's foreign debt servicing expenditures totalled \$3.6 billion over the nine months from January 31 to September 30, 2024. This marks a 39.8 percent increase, \$1.02 billion more than the \$2.6 billion spent in the corresponding period of 2023, as revealed by the CBN's international payments data.

However, debt repayment is not the sole factor. Another potential contributor to reserve movements is the CBN's intervention in the foreign exchange (FX) market.

Typically, such interventions aim to stabilise the naira by supplying dollars to meet demand. Yet, given the recent depreciation of the naira, it appears unlikely that significant interventions have taken place.

Instead, the weak supply and high demand for foreign exchange may indicate minimal intervention, leaving debt repayment as the more probable cause of the current decline.

That said, it is essential to contextualise these fluctuations. A decline over a few days does not necessarily signify a sustained trend. Ehinmosan aptly advises caution, suggesting that a clearer picture would emerge after observing reserve movements over a more extended period.

Short-term changes could just as easily reverse, highlighting the day-to-day volatility inherent in such metrics".

The decline in reserves highlights the ongoing financial strain posed by Nigeria's external obligations and the delicate balance the CBN must maintain between meeting debt repayments and stabilising the foreign exchange market.

"What the CBN has been doing to ensure that the exchange rate is stable, and we have been seeing evidence of that anyway. So for me, those are the two possibilities that will have led to that drop in reserves and in any case, that is what the reserves are meant for," Yusuf said.

Tariff Barriers, Sluggish Growth Weaken Intra-Africa Trade to \$190b

ntra-African trade's value has declined to \$190.9 billion, demonstrating persistent challenges the regional economies continue to face in trading with one another under the continental common market, blamed on both tariff and non-tariff barriers.

As a result, the share of intra-African trade in total has declined to 14.4 per cent, from 14.7 per cent in 2022, according to a report by African Export-Import Bank (Afreximbank).

In 2022, intra-Africa trade $\begin{array}{ll} made \,an\,impressive\,growth\,of\,20.6\\ per\ cent\ but\ since\ then,\ has \end{array}$ depleted, instead of improving. The report notes that Southern Africa recorded the highest share of trade within the continent, at 41.1 per cent, followed by West Africa (23.4 per cent), East Africa (16.4 per cent), North Africa (12.3 per cent) and Central Africa (6.8 percent).

The biggest trading nation, South Africa, continues to be the largest intra-African trading country, with its trade within the conti-nent valued at \$39.2 billion, though a slight decrease from \$39.9 billion.

Côte d'Ivoire came in second at \$9 billion, accounting for about five per cent of the continent's total intra-African trade. Mali emerged third, with its trade within the region growing by 18.1 per cent to \$8.9 billion from \$7.6 billion, accounting for 4.7 per cent of total intra-African trade. Egypt followed, with its trade within Africa growing by 11.4 per cent to \$8.3 billion, accounting for 4.3 per cent of total intra-African trade.

Additional contributors to intra-African trade are Nigeria, the Democratic Republic of Congo, Zimbabwe, Zambia, Namibia and Uganda, which collectively accounted for 22.4 per cent of the intra-African total trade.

The report notes that major African exporting countries were confronted with significant challenges arising from a difficult global environment characterised by heightened geopolitical tensions, subdued global demand and sluggish economic growth.

Following the remarkable growth of 20.6 per cent to \$1.4 trillion in merchandise trade in 2022, Africa's trade dipped, contracting by 4.6 per cent to \$1.3 trillion at the end of 2023 and less than a trillion last year. "The contraction can also be partly attributed to various factors, including the war in Ukraine and an escalation of the conflict between Israel and Gaza, which led to increased policy uncertainty and persistently restrictive interest rates with dampening effects on investment and trade," the report said. Africa's merchandise exports declined to \$695.2 billion in 2023 from \$705.2 billion in 2022 while merchandise imports contracted by 1.1 per cent to \$702.7 billion from the strong growth of 17.1 per cent recorded the previous year. According to the United Nations Economic Commission for Africa (UNECA), African countries continue to trade with the rest of the world more than among themselves and the envisaged benefits of Africa's trade agreement are yet to be felt by member countries as evidenced by the declining intra-Africa trade as a share of global trade.



ural Electrification Agency (REA) has advanced the implementation of the Africa Mini-grids Programme, as it awarded 18 renewable energy developers with \$5.91 million grant agreements for the development of 23 additional mini-grids across six geo-political zones in Nigeria.

Launched in 2022 and currently active in 21 countries, the Africa Mini-Grids Program (AMP) is being funded by the Global Environment Facility (GEF) and supported by the United Nations Development Program (UNDP) in Nigeria.

According to REA, 23 agricultural sites have been prioritized for the pilot phase of AMP. These sites are centered on diverse agricultural activities including grain processing; enhancing energy efficiency in staple food production, non-grain processing; strengthening support and value addition for cash crops and other agro byproducts and Cold Storage; to reduce post-harvest losses and enabling access to cooling and refrigeration solutions.

Speaking on the Agency's partnership with the GEF and UNDP, chief executive officer of REA, Abba Abubakar Aliyu, explained that the AMP aligns with the federal government's focus on the optimising decentralised renewable energy solutions to catalyse growth and unlock opportunities especially in the agricultural sector.

According to him, "REA's focus on energy access for agricultural productivity is deliberate as agriculture remains a central industry that will aid economic growth and inclusion, if well harnessed. Beyond powering homes, the implementation of the AMP will energise businesses, strengthen innovation in the sector, foster job creation, and reduce energy poverty across the country."

The AMP grant award ceremony, which

was convened by the REA on Friday, sig-naled the kick off of the development of 23 additional mini-grids across six geopolitical zones in Nigeria, with capacity rangingfrom 30Kwp to 200Kwp.

This intervention is designed to impact over 70,000 Nigerians, enabling over 600 productive use connections and over 375 social connections.

GEF Operational Focal Person, Stanley Jonah, while reiterating the impact of the AMP, explained that the completion of the AMP projects will not only enhance the agricultural value chain but impact the quality of lives of rural dwellers. He explained that the GEF remains committed to the growth of the energy access ecosystem.

Also commenting on the program, UNDP Resident Representative Elsie Attafuah, who was represented by Head of Climate Change Unit, UNDP Nigeria, Muyiwa Odele, while commending the REA's project implementation culture explained that the timely delivery of the AMP energy access interventions will catalyse broader opportunities for the private sector and serve as a guide for the over 21 implementing countries in Africa.

In his remarks, AMP Programme Lead, Bala Tyoden, urged the grantees to uphold the culture of compliance and adherence to standards and specifications as well as transparency in line with the REA's mandate, adding that the REA and its partners are committed to the delivery of efficient and sustainable infrastructure to Nigerians in last-mile communities.

With a 48-month timeline, the AMPfunded mini-grids are targeted at catalysing access to energy efficient, sustainable infrastructure for small-holder farmers in lastmile communities. The programme will enable accelerated increase in the financial viability and promotion of scaled-up commercial investment in mini-grids in Nigeria.



Nigeria's Veterinary Doctors to Fight Anthrax Outbreak, Other Livestock Diseases

eterinary Doctors in the country have confirmed their readiness to combat the outbreak of anthrax and other livestock diseases as part of effort to support the food sufficiency programme of the federal government.

To achieve the feat, the doctors operating on the auspices of the Veterinary Council of Nigeria, (VCN), said that series of retreats have been put in place to enhance efficiency in the battle against the anthrax disease outbreak.

This is coming as the Veterinary Council of Nigeria lamented that the number of veterinarians in the country was not enough to handle the situation.

The Federal Ministry of Livestock Development had recently confirmed the outbreak of anthrax in a farm in Zamfara State and pleaded for vigilance and proactive measures to mitigate the risks associated with the disease.

But the Acting Registrar of VCN, Oladotun Fadipe, urged the government to take more proactive measures against the disease, saying that Nigeria needs at least two veterinarians in each local government across the nation to curb the spread.

He emphasized that many of the livestock diseases if curtailed in animals would ensure safety for human beings and contribute to the government program of food sufficiency.

Fadipe, who spoke at the weekend in Abuja at the end of the 2025 staff retreat, explained that the number of veterinarians that are trained in Nigeria today are not enough to service the system stating that outbreak of anthrax and other livestock diseases would continue if more vets are not employed.

"Prevention, they say, is better than cure



but when you go to many of the states in this country, you have very few veterinarians in the system.

"And that is why this outbreak will continue. We are calling on the government to ensure that every local government should have at least two veterinarians in their employment.

The number of vets that are trained in Nigeria today is not even enough to service the system, yet a lot of those vets are not being employed.

'So, it is a call to government that if we have vets at their duty posts and properly placed, they will detect animal diseases before ithey outbreak," he stated.

Speaking earlier, a veterinary doctor and President, Farm Alert, Dr. Femi Kayode, noted that the theme: "Enhancing efficiency and productivity in challenging times", underscore the need to step back and look inward to ensure productivity and efficiency while deploying their expertise to the world as staff of Veterinary Council of Nigeria.

Kayode spoke of the need to re-engineer the mindset of the VCN staff for work ethics and introduce technological tools such as Artificial Intelligence, (AI) to further

improve their capacity and enhance their productivity.

'It's an important thing that we're doing this today and I'm hoping that by the time this retreat is done, people will come up with a better mindset.

'People will understand the quality and the values of tools that they use to enhance productivity

"And more importantly, I think the African continent will be grateful for moments like this where we have to step back to ask ourselves critical questions to move us forward," he added.

On her part, the Deputy Registrar of VCN, Dr. Helen Oputa stated that the retreat was meant to encourage the staff and change the paradigm for dedication to work while serving the nation irrespective of challenges.

Expressing optimism about the retreat, she said: "We are seeing results in our output and everyone is already practicing what has been learnt. The theme speaks to the mindset to go through and to keep them going. We need to address their mindset and give them hope to energize them to continue pushing.'

FG empowers 27, 302 farmers in Niger

he Federal Government says it has empowered 27,302 farmers in Niger to encourage agricultural productivity and enhance food security.

The programme is being implemented in partnership with International Fund for Agricultural Development-Value Chain Development Programme (FG/IFAD-VCDP).

Mrs Hadiza Isah, the State Programme Coordinator, said this in an interview with the News Agency of Nigeria (NAN) on Saturday in Abuja, She said the beneficiaries comprising 12,095 males and 9.132 females have been empowered in rice production and value addition while 3,035 males and 2,398 females received training in cassava production.

Isah said the VCDP project is being implemented in Bida, Katcha, Wushishi, Kontagora, Shiroro, Borgu, Edati and Mokwa Local Government Areas of the state,

She said the intervention was designed to reduce poverty by increasing income of smallholder farmers, improve food security and accelerate economic growth.

Isah said the VCDP goals aimed at strengthening value chain, reduce postharvest losses, improve nutrition, increase market access, improve productivity, among others.

She said the beneficiaries were also exposed to rice and cassava processing as well as empowered communities with processing facilities in the two value

chain.


She says "at the moment the populace now have access to food and income among others.

12 Police warn motorists, begin enforcement of third-party insurance across Nigeria

olice commissioners in several states including Lagos, Kogi and Akwa Ibom, told residents that they would commence enforcement in compliance with a directive of the Inspector General of Police, Kayode Egbetokun.

The police chief had ordered that the enforcement should commence on 1 February.

The Lagos State Commis-sioner of Police, Olanrewaju Ishola, stated his position in a statement issued by the command's spokesperson, Benjamin Hundeyin.

Mr Ishola said the enforcement aligns with Mr Egbetokun's directive.

'Vehicle owners in the state are required to have, at a minimum, valid Third-Party Insurance. Those without any form of insurance are advised to obtain one immediately.

"The Nigeria Police Force warns vehicle owners and operators against non-compliance with this essential regulation.

"Failure to comply will result in strict enforcement actions, including fines, penalties, or both.

"This initiative aims to ensure vehicle owners adhere to stipulated insurance requirements, safe-guarding themselves and other road users," he said.

Mr Ishola instructed officers involved in the enforcement exercise to remain professional and courteous but firm in carrying out their duties.

He also cautioned officers that any form of incivility toward members of the public would not be tolerated.

The police commissioner, however, urged the public to cooperate with the police, emphasising that this crucial enforcement exercise benefits all parties.

In Kogi, the Commissioner of Police, Miller Dantawaye, ordered strict adherence to the IGP's directive across the state.

Mr Dantawaye, in a statement issued in Lokoja by the command's spokesperson, Williams Ovye-Aya, said he was expecting full compliance from Kogi motorists.

The commissioner said that the enforcement, which began on Saturday, aimed to enhance road safety and ensure that all vehicle owners comply with insurance regulations.

"These regulations are designed to protect both motorists and other road users," he said.

The commissioner urged the people of Kogi to cooperate with the police officers carrying out enforcement duties to avoid unnecessary challenges.

He warned that failure to com-ply with the directive would attract legal consequences."

The commissioner advised all vehicle owners and road users in the state to obtain valid third-party insurance to avoid any inconveniences during enforcement.

He directed all Area Commanders, Tactical Commanders, and Divisional Police Officers to ensure full implementation of the directive while maintaining a high level of professionalism and adherence to standard procedures

In Akwa Ibom, the Commissioner of Police in the state, Baba Azare, led the monitoring team around the Uyo metropolis and Ikot Ekpene during the monitoring exercise on Saturday.

Mr Azare said the exercise was

in compliance with Section 68 of the Insurance Act and Section 312 of the 1945 Motor Vehicle Third Party Insurance Act.

'It is a legal requirement for all vehicle owners to possess valid third party insurance before operating their vehicles on public roads," he said.

He added that the exercise was 'designed to protect road users, ensure accountability and promote compliance with traffic laws."

In Kaduna, the police said they commenced the enforcement of Third Party Insurance Policy on Saturday.

The command's spokesperson, Mansir Hassan, announced this in a statement issued on Saturday in Kaduna.

Mr Hassan said that the enforcement was in line with the directive of the Inspector General of Police, Kayode Egbetokun.

He said, "The state's Commissioner of Police, Mr Rabiu Muhammad, has given directive for a full enforcement of the mandatory Third-Party Insurance Policy for motor vehicles from today, Feb. 1, 2025.

"This initiative aligns with existing laws and regulations governing safety for road users and vehicle insurance in Nigeria," he said.

According to Mr Hassan, the enforcement aims to ensure compliance with the compulsory insurance policy, which provides protec-tion for road users against liabilities arising from accidents involving insured vehicles.

"The command urges all vehicle owners and motorists to ensure that they possess valid third-party insurance coverage as soon as possible.

"Defaulters will face appropriate penalties as stipulated by the law," he said.

Can Opposition Stop The 50% Increase In Mobile Tariffs?

Since the Nigeria Communication Commission, NCC, sanctioned the 50% increase in tariff hike for telecommunication operators, opposition against the proposed increase has continued to mount in different quarters.

The telecoms regulator few days ago approved the increase in mobile tariffs, the first of such hike in more than a decade, bowing to pressure from operators struggling with surging costs amid high inflation and currency devaluation.

The Nigeria Labour Congress, (NLC), has in response to the proposed increment informed its affiliate unions and state councils to ensure total mobilization of workers and allies ahead of the February 4, nationwide mass protest against the planned tariffs hike.

The NLC, in separate letters dated January 30, to affiliate unions and state councils, through its General Secretary, Emma Ugboaja, urged them to also mobilize other Nigerians to send a serious message to the government.

The letter reads: In response to a resolution of the meeting of the National Administrative Council, NAC, to resist the proposed 50 per cent hike in the tariff of telecommunication services and all other forms of policies that afflict Nigerian workers and masses, all state councils of NLC are directed to begin immediate mobilization of members of their councils in their respective states for a one-day peaceful protest rally.

The rally shall take place in various state capitals and FCT on February 4, 2025, by 7a.m. You are expected to coordinate all affiliates in your states and work with volunteering civil society partners resident in your state for effective rally.

"The rally will serve as a warning on the dangers of imposing such an unfair increase on a struggling population the statement said.

The union demanded the immediate suspension of the tariff adjustment and called for



dialogue between the government, the regulator and union leaders.

Aside the NLC, the Socio-Economic Rights and Accountability Project, SERAP, has notified the Nigeria Communications Commission, NCC, of its pending suit challenging the governments decision to approve an increase in telecommunications tariff by 50 per cent.

In a letter last week, SERAP, through the law firm of Ebun-Olu Adegboruwa & Co, cautioned the commission on the need to desist from taking any action that would be prejudicial to the suit before the court.

Part of the letter reads: Given the increase comes at a time of economic hardship, further burdening Nigerians, many of whom struggle with poverty, unemployment, and high inflation, the hike will restrict access to telecommunications services, limiting the ability of citizens, including SERAP, to express themselves and share information, which is a fundamental human right.

Our client equally informed

us that the move has been met with public outcry and labor unions threatening nationwide action if the increase is not reversed.

Being dissatisfied with the violation of its constitutional and vested right and further attempts to carry out activities to the detriment of our clients interest and rights, take notice that the above-mentioned matter has been instituted at the Federal High Court, Abuja, seeking, inter alia, for a declaration that the tariff increase is unlawful and should be set aside with an order restraining the NCC and telecommunication companies from enforcing the tariff hike.

Our client is, therefore, seeking judicial intervention and determination of the legality of all actions and decisions in relation to the increase and planned implementation of the telecommunication tariffs, the letter said.

The question still remains, can strike and court stopped the implementation of this tariff hike? Its also important to know that the increase was long coming as the telecom operators have been pushing for this increment because of the high cost of operation.

According to the Minister Of Communication, Innovation and Digital Economy -Dr Bosun Tijani, the telecom operators had always insisted on 100 % increase but the federal government through his ministry and NCC, were able to negotiate it down to 50% because of the state of things in the country today.

In addition, he said the federal government approved the 50 per cent tariff hike for telecommunication operators to sustain the industry. According to him, the new tariff would allow telecommunication companies to be able to invest in new infrastructure and connectivity.

NCC through one of its officials said most of the protests against the price adjustment; including court actions and threats of it, are basically out of ignorance.

According to the official, most people do not know the serious consequences of what they are demanding for. Adding that the Commission only acted for the interest of the sector and the entire economy as well.

He noted that dialogue is important to educate some of these groups on why the increase is important because its also important to safeguard the economy instead of pandering to sentiments

When the Nigerian Association of Nigerian Students, NANS, wrote us, we invited them for a meeting and by the time we explained the processes and procedures, including the grave implications if we didnt do what we did, they clearly understood.

I believe every other group that would allow dialogue will also see reasons. We are going to engage everybody, even those who are said to have gone to court already. To safeguard the economy should be more important to all than pandering to sentiments, he noted.

Its yet to be seen how far the warning strike called by NLC will go in terms of adherence by other affiliated groups. Judging from the outcome of the strikes organized by the labor union in recent times, the warning strike may not have any strong effect as Nigerians have already adjusted to the harsh economy situation.

According to Peter Bosun, an economic analyst, the cost of production for manufacturers has hit the roof top and the telecommunication companies are not left out. For him, he does not see the operators rescinding on the new tariff increase as they have been crying for this increment for a long time and they are running at a loss because of the high cost of maintaining some of their facilities.

He however suggested that the telecom operators should not implement the increase immediately, they should take time to educate Nigerians more on why the increment is necessary.

By this Nigerians will be able to see reason with them. In addition, some people may also need to cut down on the number of telephone lines they have and also cut down on their calls, he noted

The model also reduces memory usage and is more cost-effective than other competitors in the market. Aside from its incredible performance, the making of the model reportedly cost \$6 million, compared to OpenAI's ChatGPT-4 which costs close to \$100 million.

With DeepSeek's recent model being hailed as the most cost-efficient in the market, it may have struck a chord, pushing OpenAI to act. According to its blog post, the company mentioned that the o3-Mini model is the 'most cost-efficient' in their reasoning series. "We're releasing OpenAI o3mini, the newest, most cost-efficient model in our reasoning series, available in both ChatGPT and the API today," the blog post read.

In its statement, the company also teased some of the capabilities of the new model, noting that it advances what smaller models can achieve. "Previewed in December 2024?, this powerful and fast model advances the boundaries of what small models can achieve (...) all while maintaining the low cost and reduced latency of OpenAI o1-mini," OpenAI added.

According to its statement, the artificial intelligence company will allow users to enjoy the reasoning capabilities of the models for free for the first time, while allowing paid users to enjoy three times the daily message limit, pushing it from 50 to 150. The firm is opening this up to boost the usage of the new line of reasoning models. The new model, which comes in low, medium, and high versions, will provide users with better answers for more inference.

The company's "o" family of AI models focuses majorly on reasoning tasks. This means that they are less creative compared to the GPT family models, but they have a chain of thought reasoning included in their models. This allows them to solve complex problems, build better structure codes, and backtrack on wrong analysis. While the new model is worse than the o1-Mini in general knowledge and multilingual chain of thought, it performs better at coding, factuality, and every other benchmark.

DeepSeek breakthrough and its effects

The breakthrough achieved by DeepSeek with its AI model, which delivered better results than OpenAI's AI model, caused a bit of a stir in the United States tech industry. Aside from the buzz, the breakthrough also wiped off about \$1 trillion from the US tech market, with Nvidia shedding \$600 billion in market value. The development has also called into question the demand for its expensive AI chips in the future.

The efficiency gap is coming from the novel approach that DeeepSeek took in its model architecture. While artificial companies in the US were trying to increase the computing power of their models, DeepSeek was able to streamline how the models process information, leading to more efficiency. The pressure was cranked up a notch when Chinese tech company Alibaba launched its Qwen2.5 Max.

Meanwhile, o3-Mini will be looking at increasing the gap, with the model running 24% faster than the previous model. It also matches some older models and beats others on key benchmarks. While its pricing is quite competitive, it is higher than that of DeepSeek's R1. The o3-Mini is priced at \$0.55 per million input tokens, and \$4.40 per million output tokens, while DeepSeek is priced at \$0.14 and \$2.19 for the same volumes.

Certainly, 40 years ago there was no internet in the way it is understood today. Toothbrushes were primarily operated by a vigorous motion of the wrist rather than an electric current. And a reboot was something most people associated with a new pair of wellies.

To be fair, the word "reboot" goes back more than four decades, but it has only recently become associated with everyday appliances. There is even oven that demanded a reboot after its clock got terribly confused about daylight saving time, and a car that refused to go into gear without a software update and a restart.

Chen has only to look as far as his own employer: It's been almost 40 years since Windows was first released. Users soon became accustomed to performing regular restarts to keep the system stable. This became an unwanted feature of the operating system as time went by thanks to a never-ending stream of updates, some of which require the computer to be turned off and on.

The same applies to consoles, where once the insertion of a cartridge and a flick of the on switch was enough to kick off a few hours of mindless fun, now, if updates have not been assiduously applied, there can be a substantial wait while patches are downloaded, applied, and the inevitable reboot occurs. This, we're told, is progress. Four decades ago, the idea of a stranger in an online forum suggesting that a toothbrush must be rebooted to make it work would have been laughable. Now everything seems to need an update and a reboot. While technology has improved hugely over the years, the acceptance that everything needs to be "smart" is dumb.

And as for Chen? "Oh, by the way, my attempts to reboot the electric toothbrush were unsuccessful. I had to replace it."

Hopefully not with something powered by Copilot: "I've auto-signed you up for Microsoft Dentistry 365. It'll only cost a molar or two."

Federal High Court Affirms \$87.9m Fines, Interest Imposed on MTN By FIRS

Justice Ayokunle Faji of the Federal High Court in Lagos has upheld the penalties and interest amounting to \$87.9 million imposed on MTN Nigeria Communication Plc by the Federal Inland Revenue Service (FIRS).

The court gave the verdict while delivering judgment in an appeal filed by FIRS against the Tax Appeal Tribunal's (TAT) decision of October 20, 2023.

Recall that the Tax Appeal Tribunal had awarded a principal sum of \$71 million on MTN but did not grant the penalties and interest that FIRS had requested.

But dissatisfied with the TAT's ruling, FIRS had approached the Federal High Court in an appeal marked FHC/L/1A/2024, urging the court to set aside the decision of the Tax Appeal Tribunal.

FIRS specifically prayed the court for an order setting aside the decision of TAT and an order directing the Appellant to pursue all penalties and interest arising from the principal sum awarded by the Tribunal in its judgment dated October 20, 2023.

In its brief of argument, FIRS posed two key issues for determination before the court, asking whether the Tribunal was correct in refusing to grant the Appellant the accumulating penalties and interest after determining that the goods and services purchased by the Respondent were subject to value-added taxes.

The tax agency also asked the court to

determine whether the Tribunal was right to apply the provisions of the Company Income Tax Act (CITA) to address assessments related to the penalties and interest arising from the operations of the Value Added Tax Act,

In response, MTN raised one main issue for determination on whether the Tribunal erred in law by setting aside the penalties and interest imposed by the FIRS on the Respondent's principal value-added tax liability.

MTN also contended that the Tribunal correctly dismissed the penalties and interest imposed on its alleged principal VAT liability and that the Tribunal accurately interpreted Sections 13(2) and (3) of the 5th Schedule to the FIRS Act. They further asserted that the Appellant's arguments regarding the applicability of these sections do not align with the Notice of Appeal and are, therefore, ineffective.

In his judgment, Justice Faji resolved all the issues canvassed by the parties against MTN Nigeria Communication Plc.

He held, "The decision of the TAT contained from page 750 of the record to the effect that interest and penalty are not due to be paid by the respondent to the appellant is hereby set aside.

"This appeal, therefore, succeeds. I grant the three reliefs sought, as prayed," the judge held.

They alleged that the commissioner "is not only dictating key financial decisions but also orchestrating plans to fill the incoming cabinets with her loyalists.

They raised the alarm that she was determined to prevent them from returning to the cabinet.

Meanwhile, a group of concerned Ilaje youths, threatened weekend to stage a protest against " the undue influence of the commissioner in Governor Aivedatiwa's government.

A statement signed by legal practitioner Comrade Igbalaye Enikanselu, the youths expressed fears that "Ondo State will suffer under his administration if the situation persists.

The life of the Governor is precious to the Ilaje race. We need to protect him and free him from the grip of the finance commissioner

They also criticized the governor's performance since assuming office following the passing of his predecessor, Governor Oluwarotimi Akeredolu, SAN.

According to them "governance has stalled due to financial constraints, delays in the recruitment of teachers and health workers, despite the governor's prior approval.

"As we speak, about 3,000 official files remain unattended to in the finance ministry, while over 1,000 files approved by the governor have not been processed due to a lack of funding from the Finance Commissioner

The youths have therefore called on Ilaje elders and political leaders "to intervene, because Governor Aiyedatiwa is being held hostage by the commissioner.

But while defending the finance commissioner, the Owo Local Government Chairman-elect, Hon. Tope Omolayo, dismissed the allegations against her describing them as baseless and illogical.

\$1.1 Billion AfDB Loan: Can Nigeria Power Up 5 million Lives by 2026?

he announcement of the \$1.1 billion loan from the African Development Bank (AfDB) has sparked a range of opinions among Nigerians. Some are optimistic, believing that this investment will finally address the long-standing power issues and bring much-needed relief to millions of households and businesses. They see it as a positive step towards economic stability and growth.

However, others are skeptical, question-ing whether the funds will be effectively utilized and whether the government can overcome the bureaucratic and infrastructural challenges that have historically hindered progress in the energy sector. Concerns about transparency, accountability, and the potential for corruption are also prevalent.

In a significant move to address Nige-ria's persistent energy crisis, the Federal Gov-ernment has secured a \$1.1 billion loan from the AfDB. This ambitious initiative aims to provide electricity to five million people by the end of 2026, marking a crucial step towards improving the country's power supply and boosting economic growth. Retailers Now Lifting Fuel From Port Harcourt, Warri **Refineries** — PETROAN

he Petroleum Products Retail Outlet Owners Association of Nigeria says its members are now loading petroleum products from the Port Harcourt and Warrirefineries.

PETROAN said this is contrary to pre-vious doubts that the refineries owned by the Nigerian National Petroleum Company Limited were not fully operational.

PETROAN's spokesman, Joseph Obele, disclosed this in a statement on Sat-urday, saying, "PETROAN members are now loading petroleum products, including Dual-Purpose Kerosene, Automotive Gas Oil, and Premium Motor Spirits."

Obele told our correspondent that the Port Harcourt refinery is already selling petrol, diesel and kerosene to retailers while the Warri refinery is supplying only diesel and kerosene.

According to him, the renovation of the two refineries has sparked intense competi-tion that could lower the price of fuel.

"The resurgence of these refineries has sparked intense competition, expected to drive down petroleum prices. As Nigerians advocate for lower PMS prices, it is clear that competition is a crucial factor in trig-gering price reductions.

"The refineries' revitalisation has brought numerous benefits, including the eradication of adulterated diesel and kerosene from the market," Obele stressed.

He stressed that the absence of functional refineries led to a proliferation of fake petroleum products, posing significant risks to consumers.

"With the availability of original diesel and kerosene, the demand for fake prod-ucts has decreased, reducing the risk of explosions and equipment damage.

"The refineries' functionality has also contributed to a decrease in crude oil theft, which has hindered Nigeria's ability to meet OPEC production targets. As crude oil pro-duction increases, Nigeria is expected to generate more revenue and stabilise the naira," hestated.

He emphasised that the revitalised refineries have created job opportunities, with deserted depots now bustling with activity, adding that the host communities are also benefiting from empowerment programmes, which are expected to posi-tively impact insecurity and crime rates in the region the region.

The National President of PETROAN, Billy Gillis-Harry, was quoted as saying that social empowerment programmes for oil-producing host communities align with the provisions of the Petroleum Industry Act and the Nigeria Local Content Act.

Money Market Liquidity Surge: A Boost in Nigeria's Banking System

The Nigerian banking system has been buzzing with excitement this week as liquidity levels surged dramatically. Driven by cash reserve refunds and inflows from maturing Open Market Operation (OMO) bills worth a staggering N317.66 billion, the available liquidity in the financial system skyrocketed to approximately N810 billion on Tuesday, up from N402 billion the previous week.

The recent increase in liquidity levels in the Nigerian banking system has sparked a variety of comments and opinions from different stakeholders. Many analysts and financial experts have expressed optimism about the increased liquidity levels. They believe that the cash reserve refunds and inflows from maturing OMO bills will provide much-needed financial relief to the banking sector, easing funding constraints and lowering short-term interest rates. This, in turn, is expected to support broader economic activities by making credit more accessible to businesses and individuals. As one analyst put it, "The liquidity boost is a welcome development that will help stabilize the financial system and promote economic growth".

The decline in money market rates has been a significant point of discussion. With the increased liquidity, the demand for borrowing has decreased, leading to lower rates in both the open repurchase (repo) and overnight markets. This trend is seen as beneficial for the overall financial system, as it reduces the cost of borrowing and supports economic growth. A financial expert noted, "Lower money market rates will make borrowing more affordable for businesses and consumers, which is crucial for economic recovery".

Some experts have raised concerns about the sustainability of the current liquidity levels. They caution that while the immediate impact is positive, the long-term effects depend on the continued inflows from government securities and other sources. There is also a need for the Central Bank of Nigeria (CBN) to manage liquidity carefully to avoid potential inflationary pressures. "While the liquidity boost is beneficial, we must be cautious about its long-term sustainability and the potential risks of inflation," warned an economist.

The CBN Governor, Olayemi Cardoso, emphasized the need for sustained vigilance and proactive measures to maintain monetary stability. He highlighted the importance of managing the disinflation process and ensuring that the increased liquidity does not lead to unintended economic consequences. "We must remain vigilant and take proactive measures to ensure that the increased liquidity supports sustainable economic growth without causing inflation," stated Governor Cardoso. Market participants have had mixed reactions to the liquidity boost. While some welcome the increased funds and lower borrowing costs, others are cau-tious about the potential for market volatility and the impact of future FAAC disbursements, exchange rate movements, and oil production levels. A market participant commented, "The increased liquidity is positive, but we need to be mindful of potential market volatility and other economic factors that could affect stability".

There has been public discourse on the role of banks in managing liquidity and providing access to funds. Some customers have expressed frustration with cash shortages and the rationing of withdrawals, raising questions about the efficiency of the banking system. This has led to calls for greater transparency and accountability from financial institutions. "Banks need to be more transparent and accountable in managing liquidity to ensure that customers have access to their funds when needed," said a concerned customer.

The Nigerian banking system experienced a significant increase in liquidity levels last week, driven by cash reserve refunds and inflows from maturing Open Market Operation (OMO) bills worth N317.66 billion. This surge in liquidity pushed the available funds in the financial system to approximately N810 billion recently, up from N402 billion the previous week. The Central Bank of Nigeria (CBN) plays a crucial role in managing the liquidity levels within the banking system. One of the tools it uses is the Cash Reserve Requirement (CRR), which mandates that banks hold a certain percentage of their deposits as reserves with the CBN. Recently, the CBN refunded a portion of these reserves to the banks, significantly boosting their liquidity positions. In addition to the CRR refunds, the inflows from maturing OMO bills also contributed to the increased liquidity.

OMO bills are short-term securities issued by the CBN to manage the money supply in the economy. When these bills mature, the funds are returned to the banks, increasing their available liquidity.

The increase in liquidity had a notable impact on money market rates. With more funds available, the demand for borrowing decreased, leading to a decline in interest rates. The Nigerian Interbank Offered Rate (NIBOR) showed mixed trends across different tenors. The overnight and 1-month rates dropped by 0.14% and 0.03%, respectively, closing at 26.86% and 27.35%. However, the 3month rate rose by 0.26% to 28.46%, while the 6-month rate remained

unchanged at 28.93%.

Additionally, key money market indicators like the open repo rate (OPR) and overnight lending rate declined by 0.08% and 0.11%, respectively, closing at 26.50% and 27.00%. These lower rates reflect the increased liquidity in the system and the reduced demand for borrowing.

The increased liquidity levels have several implications for the banking sector. Firstly, banks now have more funds available to lend to businesses and individuals, potentially boosting economic activity. This increased lending capacity can support various sectors of the economy, including manufacturing, agriculture, and services.

Secondly, the lower interest rates make borrowing more affordable for businesses and consumers. This can lead to increased investment and spending, further stimulating economic growth. However, it is essential for banks to manage their lending practices prudently to avoid the risk of non-performing loans.

Goingforward, analysts anticipate a liquidity-rich environment in the coming weeks. Additional inflows from maturing government securities, such as bonds, Treasury bills, and OMO bills, are expected to further boost liquidity levels. An estimated N3.5 trillion is expected to flow into the banking system, providing ample funds for lending and investment. However, market participants will closely monitor future FAAC disbursements, exchange rate movements, and oil production levels, as these factors will continue to influence liquidity conditions and interest rates in the financial system. The Central Bank of Nigeria will also play a critical role in managing liquidity to ensure monetary stability and support economic growth.
